- Delivery will take place under the conditions of Incoterms 2020/DDP - at the warehouse of the buyer in the Republic of Moldova, Chisinau Municipality, 3, Mesterul Manole Street, (Oil Housing, CET Source1), by road or railway transport.

14. Technical possibilities for the reception/unloading of fuel oil by railway transport — up to 24 tanks per day and in the case of road transport maximum 2 transport units simultaneously.

15. Contract performance guarantee - 1% of the value of the negotiated contract.

16. Bids are presented in the currency: MD Lei, Euro, US dollars. The negotiation of offers submitted in foreign currency will take place in MD Lei at the exchange rate of the National Bank of the Republic of Moldova on the date of the negotiation of bids.

17. Assessment criterion applied for the award of the contract: negotiated price.


21. Persons authorized to assist in the opening of bids: the negotiating committee.

**IMPORTANT:** Based on Order No. 37 of 15.09.2022, by derogation from the provisions of the Tax Code No. 1163/1997, Customs Code of the Republic of Moldova No. 1149/2000, Law No. 1380/1997 on Customs Duty and Law No. 172/2014 on approval of the Combined Nomenclature of Goods for a period not exceeding May 31, 2023, economic operators shall be exempted from value added tax, excise duty and customs duty, by placing under the customs import procedure the fuel oil purchased by SA “Termoelectrica”.
